The level of language communication varies from person to person, and there is no internationally recognized standard for reference. To have a clear understanding of the maid's communication skills, the center strongly recommends that prospective employers, before deciding to hire a maid, conduct a video interview and test the maid's language ability to see if they can meet the employer's expectations. In order to avoid unnecessary misunderstandings between the employer and the employee due to language communication difficulties in the future.
