Language Skills 語言能力

To understand the helper's communication skills clearly, the center strongly recommends that prospective employers conduct a video interview and test the helper's language ability to meet the employer's expectations before hiring a helper. To avoid unnecessary misunderstandings between the employer and the employee due to language communication difficulties in the future.
