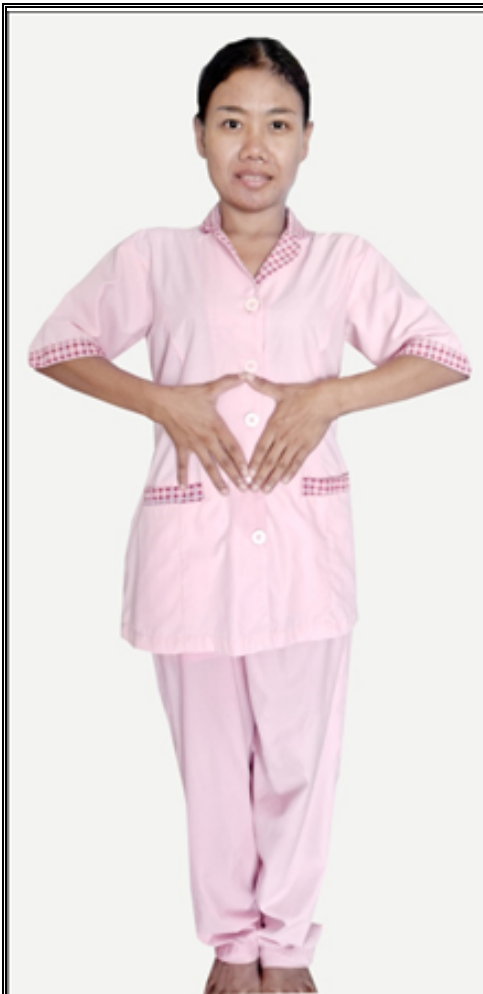

**Language Skills 語言能力**

語言溝通水平因人而異，國際上沒有認可的標準可供參考。要清楚瞭解女傭的溝通能力，本中心強烈建議準僱主，在決定聘請女傭前，務必親自視像面試及測試女傭的語言表達能力，能否達到僱主本人的期望。以免將來僱傭雙方因言語溝通困難，而產生不必要的誤解。

The level of language communication varies from person to person, and there is no internationally recognized standard for reference. To have a clear understanding of the maid's communication skills, the center strongly recommends that prospective employers, before deciding to hire a maid, conduct a video interview and test the maid's language ability to see if they can meet the employer's expectations. In order to avoid unnecessary misunderstandings between the employer and the employee due to language communication difficulties in the future.
